# 10. Members Reports:

Cllrs. D. Evans, C. J. Holmes and J. B. Johnson reported that they had attended a meeting at BCBC in regard of the devolution of services from Bridgend County Borough Councils to Town & Community Councils due to current financial pressures. BCBC need to save £50 million over the next four years and are exploring opportunities to work in partnership with other service providers so that frontline services are sustained where possible. It was acknowledged that there would inevitably be a financial implication, should the Community Council enter into a partnership agreement, and this would have to be reflected in the budget setting process. We await further information from BCBC in due course.

# 11. War Memorial, Pentice site and Bus Shelters:

The Clerk reported that the following works are now well in hand and should, with the exception of the Memorial Shelter due to the discovery of Asbestos and exterior painting, be completed by mid-December.

Project work to be completed as follows:

A. Bedford Park entrance feature – Ground works – hard-core surface and tarmac entrance. Works to the adjoining walls – rendering side wall facing Valleys to Coast property and install Estate fencing to said wall. Raised curb with raised wild flower bed next to said wall – Community Council also to explore options for seeding and maintaining this. Look at what can be done possibly tarmac around exterior of feature wall. Look at what can be done with the party wall and check with Valleys to Coast if they are responsible or for contribution towards cost.

B. Two bus shelters by common – Rendered, painted, new roof and slate tiles. Bus Shelter which was formally war memorial - Sandblasted and new roof tiles – roof structure to be checked.

C. Common entrance – bollards to be reinstated correctly.

It was agreed that the Clerk should send a suitable gift to Mrs. S. Evans from the Community Council to thank her for all her hard work to realise the completion of these projects.

**12. A.O.B.:** Cllr. M. Grabham commented that the Christmas decorations throughout the village are looking particularly good this year and thanked the Clerk for his efforts in that regard.

Cllr. H. J. David reported that The Village Carol Service will take place at the Community Centre on Friday 12<sup>th</sup> December at 6.30 pm and all are cordially invited to attend this event.
