Minutes of the meeting of Wednesday 8<sup>th</sup> November 2023 at Cefn Cribwr Community Centre and via Zoom. Chairman: Councillor C. Homes

## 2. Declarations of interest received in writing:

Cllrs. H. J. David, D. Evans and D. Dimond declared an interest in all matters concerning the Cefn Cribwr Community Association as members of that organisation.

Cllrs. A. Beckett and H. J. David declared an interest in all matters concerning Y Cefn Gwyrdd as members of that organisation.

Cllrs. K. G. Burnell and H. J. David declared an interest in all matters concerning the Cefn Cribwr Gardening Club as members of that organisation.

Cllrs K. G. Burnell and D. Dimond declared an interest in all matters concerning Cefn Cribwr Primary School as members of the Governing Body.

Cllr. K. G. Burnell declared an interest in all matters concerning the Cefn Cribwr Sports & Social Club as Secretary of that organisation.

Cllr. K. G. Burnell declared an interest in all matters concerning Bedford Park as a relation of a member of staff.

### 3. Minutes:

The minutes of the meeting of Cefn Cribwr Community Council held on Wednesday 11<sup>th</sup> October 2023, were adopted and signed as a true record.

#### 4. Matters arising:

20 *MPH Speed limit roll out:* Cllr. H. J. David reported he had asked for the 30mph section between Wesleyan and Tai Thorn to be reviewed and for the extension of the 20mph area to the west of Cefn Cross.

Caravan at Clos St. Ioan: Cllr. H. J David reported the caravan had been removed.

*Childrens Play Area at Mynydd Bach Common:* Cllr. H. J. David reported that the piece of equipment has been ordered together with several other similar items for other areas in the borough which is more cost effective. The lead time on these items is quite long, however the work will be completed in due course.

*Mynydd Ty Talwyn Energy Park*: Cllr. H. J. David reported that he would be asking for a consultation to take place in Cefn Cribwr and for a representative to meet the Community Council.

### 7. Members Report:

*High-pitched Noise at Bedford Close:* Cllr. H. J. David reported that BCBC regulatory services were investigating reports of a high-pitched noise at Bedford Close.

*Iron Works:* Cllr H. J. David reported that work has been paused following the discovery of great crested newts at the site.

52 *Cefn Road:* Cllr. H. J. David Reported that BCBC Planning Services are investigating the clearance of the land at 52 Cefn Road following reports that there is Japanese knot weed at the site.

Council noted the email correspondence from Cllr. David received over the previous month.

#### 8. Remembrance Sunday:

The Clerk confirmed the usual arrangements for Remembrance Sunday: Service at Wesleyan at 10 am followed by the Act or Remembrance at 11 am.

The Clerk reported that Mr. M. Renolds had raised concerns regarding the display of wreaths at the memorial and suggested that a method of fixing them should be investigated. It was agreed this was a conversation that was needed but acknowledged it was too late for this year. The Clerk will follow this up with Mr. Reynolds.

#### 9. Any other business:

*Cefn Cribwr Football Club:* The Clerk reported that he had been in communication with Mr. M. Davies regarding an application for a community grant towards the building of a stand at Cae Gof. Members were positive about the applications proceeding and asked the Clerk to liaise with Mr Davies in that regard.

*Car Park at Cae Gof:* The Chairman reported that he, together with other Members and the Clerk had received several communications from concerned residents since the installation of gates at the Cae Gof Car Park next to BCLC and CCAC. The Clerk had been in touch with BCBC to find out what was going on and was told that the CCAC were about to sign a 30 year lease for the car park. The Clerk asked for a copy of the lease, which was promised, but still has not been provided. He also asked that the process be paused so a wider discussion might be had to allay the concerns of residents. This request was refused by BCBC and CCAC. The lease has now been signed and the CCAC are locking the car park.

Members expressed their dissatisfaction with the situation, particularly the lack of consultation in regard of an important community asset, the inevitable bad feeling this will cause, the scapegoating of Cefn Cribwr Garage and its customers and more generally the disgraceful way the Community Council has been treated. Cllr. H. J. David apologised for the lack of transparency and communication.
