A discussion took place regarding the usefulness of the plaques, given they are incomplete. Concern was also raised that a second War Memorial would be created in the Village, which all agreed, was best avoided. On that basis, it was agreed to ask Mr. Howells to make a formal proposal to the Community Council.
