6. Budget 2018/19:

Following a thorough appraisal, and with one minor amendment, it was unanimously agreed on the proposition of Cllr. C. Holmes, seconded by Cllr. D. Evans, to accept the Budget as circulated.

9. Members Report:

Farmers Arms: Concern was raised that the new owners of the Farmers Arms seem to be making internal alterations to the ground floor of the building. It was agreed that this needed to be closely monitored, with any perceived breach of planning permission reported to BCBC.

School crossing patrol: Cllr. H. J. David reported that following a review, the position of School Crossing Patrol Officer at Cefn Cribwr Primary School is currently being advertised. This position is directly funded by BCBC.

10. Any other Business:

Dog Fouling: Cllr. I. Thomas reported that dog fouling in the village seems to have increased. Cllr. H. J. David responded that BCBC currently have two enforcement Officers. However, BCBC are about to engage the services of a private enforcement agent, who will be paid by results in a similar way that parking attendants operate. This approach has proved very successful in other areas where it has been trialed and it is anticipated this was have the same effect in the Bridgend County Borough.

Parking Bays at Gwelfor: Cllr. I. Thomas reported that a resident of Gwelfor had spoken to him regarding having lines painted to demarcate the parking bays at Gwelfor. Cllr. H. J. David responded that he was aware of this request, however, at present, BCBC have no funding available for these works.
