Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations identified during the audit:

The opening balance for 2020-21 (Line 1) in the Accounting Statement has not been rounded and is stated to two decimal
places (to the penny). However, the remainder of the Statement is rounded to the pound (£). This results in an arithmetic
error in the Accounting Statement as a whole. Lines 9 and 11 should record a balance of £85,980. We recommend that in
future years, the Council checks the arithmetic and consistency of the accounting statement before approval.
